# Introduction<sup>1</sup>

who doesn't? Trying to give fact to the public, in 2008 Silvia Celeste Brown, a medium with psychic talent, and Harrison have made a very astounding prediction on the kind of situation we are facing:

*In around 2020 a severe pneumonia-like illness will spread throughout the globe, attacking the lungs and the bronchial tubes and resisting all known treatments. Almost more baffling than the illness itself will be the fact that it will suddenly vanish as quickly as it arrived, attack again ten years later, and then disappear completely.<sup>2</sup>*

However, she was known as psychically wrong and was more inaccurate in most of her predictions, as Robert S. Lancaster has proven, amid thousands of her predictions which did not happen, make this one quite meaningless.<sup>3</sup> Also, this is not a prophecy, it is more like an educated guesstimate or forecast based on what feels. Since the Nidovirales, a virus introduced several years

ago, 1967, there is still little information on how new viruses replicate the corona. The coronavirus has been categorized into three groups, with human coronavirus (group 1), porcine infectious gastroenteritis, mouse hepatitis virus (group 2), and avian transmittable bronchitis virus (group 3), which is the most prevalent coronavirus to date and one with which thorough research has been made.<sup>4</sup>

Take for example, global warming, and the environment rapidly impending a likely Ice Age that would eradicate most life on Earth. The world's economic system is on the edge of total failure, and the struggle has begun for most around the world.

Illnesses such as HIV/AIDS, H5 and H5N1 viruses, and other pandemics threaten the world. There are over forty conflicts happening at this moment—in addition to Afghanistan and the Arab Spring, there are many such Boko Haram in the western part of Africa (Nigeria, Cameroon and Tchad) and other wars going on worldwide that we overlook. Among the best known are Creffield, Reidt, Dowie and Venta. In other words, (and by summons when they knew themselves): Josue the second, the great Witness of the end of the world, the Master of the Holy City of Zion, and the Messiah from the well of the world ... Surnames which are quite a program.

The Last Judgment by painter Hans Memling. In christian beliefs, the last judgment is an apocalyptic event where God makes a final judgment of all the people on Earth.

Prophecies of apocalyptic events that would result in the extinction of humanity, a collapse of civilization, or the annihilation of the earth have been made since at least the beginning of the Common Era.<sup>5</sup> Most predictions are related to Monotheist religions, often established for, or comparable to the eschatological incidents portrayed in the Holy Scriptures.

Christian prophecies normally denote to events like The Rapture, The Great Tribulation, The Last Judgment, and The Second Coming of Christ. Many religious-related end-time events are predicted to occur within the lifetime of the person making the prediction, who often quote the Bible, and in particular The New Testament, as either the primary or exclusive source for the prophecies.

Often this takes the form of arithmetical computations, such as trying to calculate the point where it will have been six thousand years since the believed creation of the Earth by Yahweh which according to the Talmud, marks

the deadline for the Messiah to appear.<sup>6</sup> Prophecies of the end of natural events have also been theorized by various experts and scientific groups. While these calamities are generally recognized within the scientific society as reasonable “End of The World” developments, the events and occurrences are not expected to occur for hundreds of thousands or even billions of years from now.

However, the new order of things in the human world and whoever will be put in place at the end of time, such as the announcement of a prophetic way; "the Apocalypse!" Far from designing a new terrestrial paradise, this vision announces the establishment assured of a whole new absolute:

---

*Now I saw a new heaven and a new earth, for the first heaven and the first earth had passed away. Also, there was no more sea. Then I, John I, saw the holy city, New Jerusalem, coming down out of heaven from God, prepared as a bride adorned for her husband.  
(Revelation 21:1-2)*

Nor prophecies for that matter have been overall studied. We have never established a statistic comparative of those last, if only for the most important of them. Nevertheless, we can be persuaded that such

steps would suddenly lead to a surprise finding with the fact that the absolute majority of prophecies refers especially to the end of the world. The catastrophic twilight of the civilization, glimpsed precognitive for a certain end of time, concerns more than three quarters of never given in prophecy to comments from the media.

In fact; Some experts still believe that the appearance of a new pandemic is only a matter of time. The phenomenon is comparable to the influenza virus of 1918-1919, which by some estimation has killed 20 million people worldwide. Such a pandemic would be devastating and risk spreading quickly across the globe.<sup>7</sup> Adler adds that the emergence of a new virulent, highly contagious human respiratory disease, for which there is no adequate treatment, could trigger a worldwide pandemic. If such a disease appears, by 2025, internal and transformational tensions and conflicts will not fail to explode. Indeed, nations will then strive - with insufficient capacity—to control the movements of populations seeking to avoid infection or to preserve their access to natural resources.<sup>8</sup>

So far, the new coronavirus has led to more than 115,000 infections and more than 4,000 deaths worldwide. But that's nothing compared to the flu or influenza. Only in the USA, the flu has affected an estimated 34 million persons, with over 350,000 hospitalizations and 20,000 deaths in 2020, according to the Center for Disease Control and Prevention (CDC). However, up to date, the death rate from seasonal

flu is lesser than the Coronavirus in some location. It seems that we will always battle against viruses. In recent epochs, several viruses have flown from animals to humans and generated sizable epidemics, exterminating thousands of lives. One has to remember the outbreak of the West Africa virus Ebola, that killed up to 90% of those infected, making it the most lethal epidemic in the family of Ebola.<sup>9</sup>

What lies behind this fear and panic? The answer to this question is certainly not so simple. Part of that are the media, global risk and fake news. Hence, the coronavirus reveals our vulnerability and resilience in front of the danger. No comprehensive account of the prophets has ever been undertaken. It reveals the pandemic of fear.

The world lives proudly until something we do not understand comes to remind us that we are simply human. And the media add this spirit of fear with half information and contribute to a pandemic of fear. In this book, we will replace facts, fears and fiction to bring the world to God where one finds security. Is this virus a demonstration of power from Satan or an act of God? Who is behind the scenes? Is this fear a part of the end time prophecies? These questions are legitimate and are the goals of this book.

It's certainly a moment of calamity. The populace are getting sick and dying. We see even those who were not sick have had their lives transformed by the drastic actions the Chinese, Italian, French and American

authorities have applied in order to contain the coronavirus spreading. Still, without ignoring the threats posed by the epidemic or ignoring the unfolding human misfortune, the vast majority of people are not in imminent danger of death or starvation. This book aims to give a theological aspect on how to consider this pandemic in particular, or any epidemic that outbreaks in the world.

Chapter 2 will look onto the prediction fevers of the end in the human arena, from ancient Mesopotamia to the modern world shows that mankind lingers for the end of the world since the paradise he has lost.

Chapter 3 shows that prophetism is at home in dramatic periods, almost everywhere people have set dates for the end of the world.

Chapter 4 presents and analyses the 1981 prediction of Dean Koontz of the modern Coronavirus.

Chapter 5 asks the question about the origin of the Coronavirus or Covid-19. Was it part of a hidden agenda to reduce the population of the world or something else?

Chapter 6 indicates how Leviticus seems relevant for the Modern Man, in the case of a pandemic, which kills so many.

Chapter 7 suggests some guidelines on the biblical promises that God is in control even during such context.

Above all, chapter 8 gives us the way forward. How to analyze “these things”? Is it an apocalyptic question that still challenges each one of us?

Chapter 9 looks into the Book of Revelation, possibly in the four horsemen who bring pestilence. The parallelism is notable and the biblical perspective is mostly needed.
